The Vocational Education Sector in Australia is a heavily regulated environment that is focused on quality and consistency and is aimed at ensuring that all learners receive a high standard of learning, regardless of the training organisation they chose to study with.


It is the Vocational Education and Training (VET) Quality Framework that aims to achieve improved consistency in the registration of training organisations and through the enforcement of quality standards. The VET Quality Framework is made up of:

- Standards for Registered Training Organisations (RTOs) 2015
- Fit and Proper Person Requirements
- Financial Viability Risk Assessment Requirements
- Data Provision Requirements
- Australian Qualifications Framework

The Standards for RTOs provide consistency, promote quality, protect students and aim to improve the VET sector in Australia by describing the requirements that training organisations must meet in order to provide accredited training.

## ASQA and Risk-Based Regulation

In this regulated environment in which we have built our careers, the Australia Skills Quality Authority (ASQA) ensure the outcomes of applying these Standards are achieved by monitoring training organisations, their operations and the learning programs they provide. ASQA take a risk-based approach to regulation, focusing on the most significant operational and strategic risks they identify through a variety of data sources. Compliance and performance assessments take a student-centered approach which means the practices and behaviours of your RTO are examined throughout the key phases of your student's learning journey.





## The Student Journey

ASQA take a student-centred audit approach which focuses on the student's experience with your RTO. Audits are structured around the practices and behaviours of your RTO in the key five (5) key phases of the student's learning journey.

# **Quality Assurance and Compliance Audits**

Conducting an internal compliance audit on your RTO operations will give you a clear picture of your current state of compliance against the standards for RTOs. These internal audits are conducted to reflect ASQA's student-centred approach to performance assessment and are a great way to prepare for re-registration of your RTO.

Your assigned compliance consultant and team will conduct a comprehensive internal audit to assess the RTO's compliance with quality standards and regulatory requirements and provide you with a detailed report:

- 1. Small Institution (up to 100 students): \$4,000
  - ★ Time Required: Approximately 1 to 2 weeks
  - ★ Simple RTO with single or online campus, small scope or UoCs only in single industry area, limited staff and standard compliance requirements to review.
- 2. Medium Institution (101-500 students): \$8,000
  - ★ Time Required: Approximately 2 to 4 weeks
  - ★ Average sized RTO with single campus, medium scope across selected industries, limited staff and various compliance requirements to review.
- 3. Large Institution (501+ students): \$16,000
  - ★ Time Required: Approximately 4 to 8 weeks or more
  - ★ Complex RTO with multiple campuses, large scope across multiple or specialised industries, numerous staff and various compliance requirements to review. Also includes Online RTO with 500+ students

# Pre and Post Assessment Validation Services

Validation is the quality review process that determines whether the assessment decisions made are consistent and meet the specified outcomes of the qualification and/or units of competency.

Engaging CWTS to work through this process for or with you ensures transparency and eliminates any biases ensuring the outcomes are fair to all students.

These services can support your RTO to ensure the quality and accuracy of assessment processes and outcomes. Services include the validation of assessments before they are conducted (pre-assessment) and also to verify the fairness and reliability of assessment results afterward (post-assessment).

When you apply for registration, expect a rigorous assessment that aims to ensure your organisation is fully prepared to start operating as an RTO and that it meets the Standards for RTOs.

## The Application Process

- ★ Obtain the services of an independent and qualified accountant to help you commence the development of the Financial Viability Assessment.
- ★ Follow the advice given and don't take short cuts!
